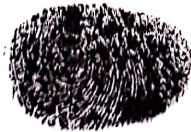

AND Whereas, with the passing years as the activities of the Trust has increased and whereas, one of the founder and Managing Trustee namely Mr. Sanjeev Kumar has desired to resign of the Trust Deed and since the place in the Trust Board has fallen vacant consequent to leaving out of Mr. Sanjeev Kumar, Son of Sh. Jagdish Prasad Sharma, R/o C-164, Manu Apartments, Mayur Vihar, Phase-I, Delhi-110091, certain clauses need to be incorporated and modified in order to ensure a continued growth and proper administration of the Trust.

Accordingly, the Board of Trustee vide Resolution dated 27th December 2019 has approved certain amendments to the Trust Deed which inter-alia, relate to appointment of Trustees, number of Trustees, management of Trust etc.

AND WHEREAS, the Founder and Managing Trustees wish to reduce the amendments approved by the Board of Trustees as set below:

NOW THIS DEED OF AMENDMENT WITNESSETH AS UNDER:

1. One new Trustee has been inducted and now, the total number of trustees are two who are the following:-

- (a) Ms. Punam Kumari, Wife of Mr. Sanjeev Kumar, resident of C-164, Manu Apartments, Mayur Vihar, Phase – 1, Delhi 110091 hereinafter designated as “Founder & Managing Trustee”; and
- (b) Mrs. Aprajita Singh, daughter of Mr. R. P. Singh, resident of A/35, Police Colony, Anishabad, Patna 800002, Bihar hereinafter designated as “Founder & Managing Trustee”.

2. Clause 4 (i) relates with Management of Trust of the Trust Deed dated 02.03.2016 is substituted by the following:-

The management of the TRUST shall vest in the Board of Trustees comprising the follows persons:- (i) Mrs. Punam Kumari, and (ii) Mrs. Aprajita Singh.

3. Clause 4 (ii) be added with Management of Trust of the Trust Deed dated 02.03.2016 is substituted by the following:-

The Founder and Managing Trustees shall hold the office of President & Vice President in rotation for three years each shall be member for lifetime.

4. New Clause 6A be inserted under – ADMINISTRATION OF TRUST

6A) Terms of Dissolution: In the event of dissolution or winding of the trust, the assets remaining as on date of dissolution shall under no circumstances be distributed among the trustees/members of the managing committee/Governing body, but the same will be transferred to another Charitable Trust/Society whose objects are similar of those of this Trust and which have valid recognitions and exemptions under section 12A/12AA and 80 G of the Income Tax Act 1961 as amended from time to time including any other exemptions as required to run a trust for charitable or activities for advancement of any other object of general public utility only with the consent of the founder trustees.

5. That all other clauses of TRUST DEED dated March 02,2016 shall remain same and it is made clear that from now onwards, all the above mentioned two TRUSTEES shall be treated and considered as "Founder & Managing Trustee".
